
It is free and available for anyone to access with a Healthed account.

Is this activity accredited?


Yes, this activity is accredited with the RACGP and ACRRM for the following CPD types:

What do I need to do to get the CPD hours?



How do I get my certificate?



If my patients can't do it online, can I print the CogDrisk assessment for them to complete together?

Unfortunately this is an online risk assessment and a risk score and report is calculated based on the information the patient submits online. We suggest if possible, to go through the assessment with them online or have a nurse help them to complete it online. This will take approximately 20 minutes to complete. https://cogdrisk.neura.edu.au/

After completing the CogDrisk assessment, where do my patients' results go? Is there a report they can download for the consultation?

Yes, after the patient completes the CogDrisk assessment online, a personalised report (PDF copy) can be downloaded at the end of the assessment. This is only accessible for the patient or whoever is completing the assessment online.

I don't have any patients that fit the criteria (45-65 years of age). Can I still do this activity?

Yes, you can. Individuals 18 years and above can complete the CogDrisk assessment. Although the risk assessment does not provide a risk score for people under 40 years of age (because there have not been enough studies of this age-group to generate a valid risk score), all patients over 18 years who complete the CogDrisk assessment will still be provided with a downloadable report with advice on risk reduction based on the patient's risk if they have the same profile at an older age.

When do I need to complete this activity by?

Learners will have until Sunday 31st December to complete this activity. CPD hours will be uploaded into your RACGP or ACRRM account for 2023.
